ARTICLES OF INCORPORATION OF IGLESIAS GROUP, INC.

The undersigned, acting as incorporator of a corporation to be formed under the provisions, of the laws of the State of Florida, hereby adopts the following Articles of Incorporation for such corporation, to be filed with the Secretary of State of the State of Florida:

ARTICLE I

The name of the corporation shall be IGLESIAS GROUP, INC. The principal place of business of this corporation shall be 9730 SW 8 Street, Miami, Florida 33174.

ARTICLE II

The Corporation shall have perpetual existence commencing at the filing of the Articles of Incorporation with Department of State.

The general nature of the business to be carried out by the Corporation as follows:

1) To carry on any and all lawful purposes not specifically prohibited or limited by Chapter 607, Florida Statutes.

A Board of Directors consisting of not less than One (1) nor more than seven (7) members shall be elected at the first annual meeting of stockholders and at each annual meeting thereafter. Unless otherwise prescribed by law, the entire voting power to elect Directors_ and for all other purposes shall be vested exclusively in the holders of the outstanding shares of common stock with voting rights of the corporation.
