ARTICLE I NAME

The French Club, Inc.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

The French Club's main objective is to advance friendly relations between France and other countries in the world. The French Club also seeks to promote France, its culture, and language locally and internationally, through the participation and organization of French pavilions and booths during festivals and fairs such as the World of Nations in Jacksonville. The participation in such events will include exhibition of French documentation, art, and products. The French Club will provide cultural entertainment on certain occasions (based on circumstances of service and cost).

ARTICLE IV MANNER OF ELECTION OF DIRECTORS

The Board of Directors is elected for three years by the members of the French Club, except for the Chair who is elected every six years. The Board of Directors is composed of the Chair, Vice-Chair, Treasurer, Secretary, and Public Relations Officer. The Club advisor is appointed and removed by the Chair.
