# ARTICLES OF INCORPORATION OF ACINAR CORP.

The undersigned does hereby subscribe to, acknowledge and files the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

## ARTICLE I - NAME

The name of this corporation is ACINAR CORP.

## ARTICLE II - PURPOSE

#### ARTICLE VI - PREEMPTIVE RIGHTS
