The undersigned does hereby form a corporation under the laws of the State of Florida under the corporate name of NEW POINT CONSTRUCTION INC., and hereby adopts the following atticles of Incorporation:

ARTICLE I

The name of the corporation shall be NEW POINT CONSTRUCTION INC.located in the city of Cape Coral, County of Lee, State of Florida.

ARTICLE II

The Corporation may engage in any activity or business permitted under the laws of the United States of America and the State of Florida.

ARTICLE III

The amount of capital stock of this corporation shall be 100 shares of non par value stock, which said stock shall be unassessable to be held, sold, and paid for at such time and in such manner as the Board of Directors may from time to time determine. All of the capital stock shall be common stock.

ARTICLE IV

The Corporation shall commence business on filing with the Secretary of State and shall have perpetual existence, except that it may be dissolved, as provided by law.

ARTICLE V

The principal place for the operation of its business shall be 1201 Hancock Bridge Parkway, Cape Coral, County of Lee, in the State of Florida 33990. That said Corporation shall have the right and authority to do business at such other place or places within or without the State_of Florida as the Corporation may, by resolution, designate.

ARTICLE VI

ARTICLE VIII

ARTICLE IX

The directors and officers shall be elected by the shareholders at their annual meeting, which will be held at the principal office of the Corporation, or at such other place as may be provided by the bylaws, or may otherwise be agreed upon, on the third Thursday of February of each and every year and the annual directors' meeting shall be held immediately after the adjournment of the annual shareholders meeting.

ARTICLE X

The amount of indebtedness of liability to which the corporation, at any time, may subject itself shall be unlimited.

ARTICLE XI

Each shareholder, upon the sale for cash of any new stock of this corporation, shall have the right to purchase his prorata share thereof (as nearly as may be done without issuance of <u>fractional</u> shares) at the price at which it is offered to others.

ARTICLE XII

The initial bylaws of this corporation shall be adopted by the Board of Directors. The bylaws may be amended from time to time by either the shareholders or the directors. The shareholders may amend, alter or repeal any bylaw adopted by the directors. The directors may not alter, amend or repeal any bylaw adopted by the shareholders, nor may the directors adopt bylaws which would be in conflict with the bylaws adopted by the shareholders.

ARTICLE XIII

Any subscriber or shareholder present at any meeting, either in person, or by proxy, and any directors present in person at any meeting of the Board of Directors shall conclusively be deemed to have received proper notice of such meeting unless he shall make objection at such meeting to any defect or insufficiency of notice.

ARTICLE XIV

Each director and officer of the Corporation, whether or not then in office, shall be indemnified by the corporation against all cost and expenses reasonably incurred or imposed upon him in connection with or arising out of any claim, demand, action, suit or proceeding in which he may be involved or to which he may be made a party by reason of his being or having been a director or officer of the Corporation,

Nothing herein contained shall create liability in the events above described or prevent the authorized approval of such contracts in any other manner permitted by law.
