ARTICLES OF INCORPORATION OF PSI HEALTH SERVICES, INC.

ARTICLE I NAME

The name of this Corporation is PSI Health Services, Inc.

ARTICLE II DURATION

This Corporation shall have perpetual existence. The effective date of this Corporation shall be the date of filing of these Articles.

ARTICLE III PURPOSE

The general purposes for which the Corporation is organized are the following:
