## Articles of Incorporation

## SOMA PILED AND SE MARY & JESUS REYES COMMERCIAL CLEANING, INC

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

- The name of the Corporation is MARY & JESUS REYES Article 1: Name. COMMERCIAL CLEANING, INC.
  - Article 2: Duration. The duration of the Corporation is perpetual.
  - Article 3: Purpose. The general purposes for which the Corporation is organized are the following:
- A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.
- B. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.
- Article 4: Capital Stock. The aggregate number of shares which the Corporation is authorized to issue is 100 (One Hundred) shares of common stock. Such shares shall be of a single class and shall have a par value of \$1.00 (One Dollar) per share. The initial Shareholders are JESUS REYES and MARY REYES and each will retain 50% ownership of the stock.
- Article 5: Principal Office, Initial Registered Office and Agent. The street address of the principal office and initial registered office of the Corporation is 2204 20 STREET CT WEST, BRADENTON, FL 34205 and the name of the initial Registered Agent at that address is JESUS REYES.
- Article 6: Initial Board of Directors. The number of Directors constituting the initial Board of Directors is 2. The number of Directors may be increased from time to time in accordance with the bylaws but shall never be less than 1 (One). The name and address of the initial directors of the corporation are as follows: JESUS REYES, 2204 20 STREET CT WEST, BRADENTON, FL 34205; MARY REYES, 2204 20 STREET CT WEST, BRADENTON, FL 34205.
- Article 7: Incorporator. The name and address of the incorporator is JESUS REYES, 2204 20 STREET CT WEST, BRADENTON, FL 34205.

Article 8: Amendment. The Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment to them, any right conferred upon the shareholders is subject to the reservation.

Article 9: Indemnification. The Corporation shall indemnify each Officer and Director, including former Officers and Directors, to the full extent permitted by law.

Article 10: Bylaws. The power to adopt, amend and repeal Bylaws shall be vested in the Board of Directors, but all alterations, amendments and repeals of the Bylaws must be approved by a majority of the Shareholders.
