ARTICLES OF INCORPORATION OF Ideo Co.

a Florida Corporation

The undersigned incorporator, for the purposes of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is Ideo Co. (the "Corporation").
