ARTICLES OF INCORPORATION

OF

ADRIAN LEGASPI, M.D., P.A.

ARTICLE I - NAME

The name of the corporation is Adrian Legaspi, M.D., P.A. (hereinafter the "Corporation").

ARTICLE II - PURPOSE
