The undersigned incorporator, for the purpose of forming a professional service corporation for the practice of architecture under the provisions of Chapter 621, <u>Florida Statutes</u>, the "Professional Service Corporation Act", hereby adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation shall be George G. Demmy, Architect, P.A.

ARTICLE II. PURPOSE

The corporation is organized for the purpose of engaging in the practice of architecture.
