**ARTICLES OF INCORPORATION**

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopt the following Articles of Incorporation:

**ARTICLE ONE - NAME**

**ARTICLE THREE - CORPORATE DURATION**

This duration of the corporation is perpetual.


