**THE UNDERSIGNED**, acting as sole incorporator of **INSIGHT INVESTMENT GROUP, INC.** under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

**ARTICLE I**

**Name**

The name of the corporation shall be **INSIGHT INVESTMENT GROUP, INC.**

**ARTICLE II**

**Shares**

The number of shares which the corporation shall have authority to issue is Ten Thousand (10,000), consisting of a single class of common stock, One Cent (\$0.01) par value per share.

### **Initial Board of Directors**


