

**ARTICLES OF INCORPORATION  
OF

**ARTICLE I. CORPORATE NAME.**

**The name of this corporation is M M K Marketing, Inc.**

**ARTICLE II. NATURE OF BUSINESS AND POWERS.**

**The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.**

**ARTICLE III. CAPITAL STOCK.**

**The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is 10,000 shares of common stock without par value.**

**ARTICLE IV. TERM OF EXISTENCE.**

**The Corporation shall have perpetual existence.**

**ARTICLE V. REGISTERED AGENT AND INITIAL REGISTERED OFFICE.**
