

The name of the corporation shall be: **STRIT, INC.**



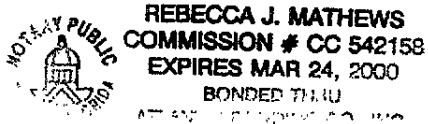


