# ARTICLES OF INCORPORATION OF NAPLESSTOCK, INC

### ARTICLE I - NAME

The name of this corporation is NAPLESSTOCK, INC.

### ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

### ARTICLE III - PURPOSE
