ARTICLES OF INCORPORATION

In compliance with the requirements of Florida Statutes, Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is: Beth G. Smith, PA

ARTICLE II

The existence of the corporation shall begin on: March 15th, 1999

ARTICLE III

The street address of the principal office of the Corporation is: 7220 Westpointe Boulevard, Suite 1420, Orlando, Florida 32835.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 10,000, all of which shall be Common Shares. 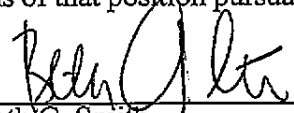
