ARTICLE V. TERM OF EXISTENCE

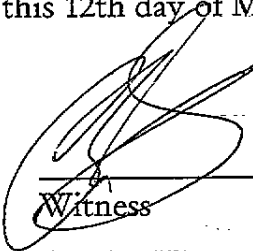

ARTICLE VI. ADDRESS

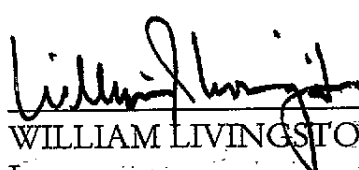
The street and mailing address of the initial principal office of this corporation in the State of Florida is 185 Cypress Point Parkway, Palm Coast, Florida 32164. The
