#### ARTICLE I. CORPORATE NAME

The name of this corporation is: LHZ ASSOCIATES, INCORPORATED.

# ARTICLE II. NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this corporation is to engage in the business of providing automotive sales consultation and contractually related services, along with any and all other business permitted under the laws of the United States of America and the great state of Florida.
