**ARTICLE I - NAME**

The name of this Corporation is BROWN STORAGE RENTALS, INC.

**ARTICLE II - DURATION**

This Corporation shall have a perpetual existence commencing on March 29, 1999.

**ARTICLE III - PURPOSE**

The Corporation may engage in any activity or business under the Laws of the United States and of the State of Florida, but specifically for the purpose of rental of trailers, trucks, rental of real property, trailer repair and maintenance .

**ARTICLE IV - CAPITAL STOCK**
