## ARTICLES OF INCORPORATION OF

OLD BLUE OF PALM BEACH, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE 1. NAME. The name of the corporation is: OLD BLUE OF PALM BEACH, INC.
