As per phone conversation to you office I am appealing the revocation we received stating we were dissolved September 22,2000. I am protesting this for several reasons. First, the dissolution notice is the first notice we have received from your office. In the statement you sent you stated we were sent a notice at the beginning of the year then a second mid year and then a final notice which we did receive. The notice was sent to John Long the secretary at his private residence. He has never seen notice before this one came. Why were the notices not sent to our corporate office? We are set up with the Florida Department of Revenue at this address as well as the IRS with our EIN number to pay our 941's. Is there a record of where the first two notices were sent? John is diligent to take care of business and claims to never have seen these two former notices.

Enclosed are other documents showing our other address and post office box from the State and County. We realize that the fact that even though this is our first full year of business, ignorance of what to expect from the State is not normally a valid reason to waive normal procedures. However, due to the address anomaly, we believe it is unfair to charge us such a high fee when this is the first notice we've received. We will be happy to pay the normal fee that would be charged at the beginning of the year and will do so immediately.
