ARTICLES OF INCORPORATION

OF

NET GRINDER CORP.

The undersigned subscriber to these Articles of Incorporation, each a natural person, competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida, Florida Statutes 607.001 et. seg., and the corporation so formed shall be for profit.

ARTICLE I-NAME

The name of the corporation shall be: NET GRINDER CORP.

ARTICLE II-TERM OF EXISTENCE

This corporation is to exist perpetually and shall commence at the time of filing these Articles.

ARTICLE III-NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation shall be sale and internet services, monitoring services, design of websites, all other related internet services and all other business now or in the future lawful in the State of Florida or any other jurisdiction where the corporation transacts business.


