ARTICLES OF INCORPORATION OF LEXI'S UNIQUE BOTIQUE, INC.

PATOS AND SELLED

ARTICLE 1. - NAME

The name of this corporation is LEXI'S UNIQUE BOTIQUE, INC.

ARTICLE 2. - DURATION

This corporation shall exist perpetually unless dissolved according to Florida law.
