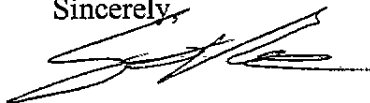

ARTICLES OF INCORPORATION OF

The name of the initial registered agent is SCOTT EVANS whose registered office is located at the place of business stated in Article 2 above.

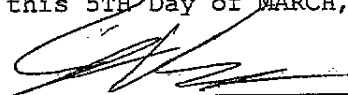
