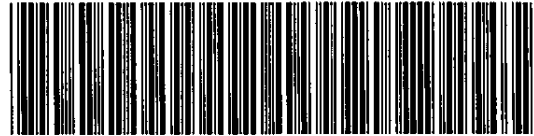

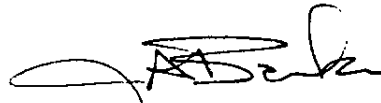

ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION
OF
SUNGOLD HOLDINGS, INC.

Pursuant to the provisions of the Florida General Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Restated Articles of Incorporation:

1. The name of the corporation is SUNGOLD HOLDINGS, INC. and the original date of filing/authorization in Florida was March 17, 1999.

2. The following amendment of the Articles of Incorporation was adopted by the Board of Directors of the corporation on this date, in the manner prescribed by the Florida General Corporation Act:

Article I is amended by changing the name of the corporation from "SUNGOLD HOLDINGS, INC.", so that Article I shall now read:

"The name of the Corporation is: "JRC FAMILY, INC."

3. The following amendment of the Articles of Incorporation was adopted by the Board of Directors of the corporation on this date, in the manner prescribed by the Florida General Corporation Act:

Article III is amended by changing the number of authorized shares shall be increased to 3000 shares, so that Article III shall now read:

"The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is three thousand (3000), all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote. The corporation will have only one class of shares."

4. The number of shares of the corporation outstanding at the time of the adoption was 1400, and the number of units entitled to vote thereon was 1400.

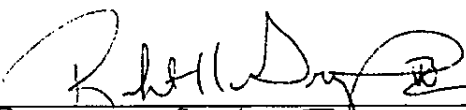
5. The number of shares voted in favor of such amendment was sufficient for approval.

6. Such amendment does not effect a change in the amount of stated capital.

7. This amendment shall be effective upon filing.
