## ARTICLES OF INCORPORATION

I, the undersigned incorporator, for the purpose of forming a corporation under Florida law, hereby adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the corporation shall be:

PRECISE HOME INSPECTIONS, INC.

ARTICLE II: PURPOSE

PRECISE HOME INSPECTIONS, INC. shall be organized under Florida Statute Chapter 607 as a for-profit corporation with the purpose of providing residential home inspections or commercial property inspections.

PRECISE EHOME INSPECTIONS, INC. may invest its corporate funds into real estate, mortgages, stocks, bonds, and any other type of investments, and may own real and personal property necessary for the rendering of the professional services authorized hereby.

ARTICLE III: PRINCIPAL PLACE OF BUSINESS

The principal place of business of this corporation shall be in Palm Beach County, Florida. The Principal Place of Business will be the same as the mailing address.

ARTICLE IV: MAILING ADDRESS

ARTICLE V: SHARES

The maximum number of shares of stock that this for profit corporation is authorized to have outstanding at any one time shall be fifty (50) shares with an initial par value of one hundred dollars (\$100.00) per share, all of which shall be common stock of the same class.

ARTICLE VI: OWNERSHIP OF SHARES

Richard Hackeman, acting as Director of PRECISE = HOME\_INSPECTIONS, INC., shall be issued and hold all fifty (50) shares of common stock.

ARTICLE VII: EXISTENCE

The corporation shall have perpetual existence.

ARTICLE VIII: BOARD OF DIRECTORS/INCORPORATORS

The name and post office address of the first board of directors/incorporators, who subject to the provisions of these Articles

of Incorporation shall hold office for the first year of the corporation's existence or until their successors are elected and have qualified, are as follows:

## ARTICLE IX: MANAGEMENT/AFFILIATION

In furtherance and not in limitation of the powers conferred by statute, the following specific provisions are made for the regulation of the business and conduct of the affairs of PRECISE HOME INSPECTIONS, INC.

- (1) Such director/shareholder of PRECISE HOME INSPECTIONS, INC. shall from time to time create, readdress and amend by-laws for the corporation as the director/shareholder should see fit.
- (2) Subject always to such by-laws as may be adopted from time to time by the stockholders, the board of directors of PRECISE HOME INSPECTIONS, INC. is expressly authorized to adopt, alter and amend the by-laws of the corporation, but any by-law adopted, altered or amended by the directors may be altered, amended or repealed by the stockholders.

(4) Subject to the restrictions, if any, as are herein expressed and such further restrictions, if any as may be set forth in the by-laws (not attached), the board of directors of PRECISE HOME INSPECTIONS, INC. shall have the general management and control of the business and may exercise all of the powers of the corporation except such as may be by statute, or by the articles of incorporation or amendment thereto, or by the by-laws as constituted from time to time, expressly conferred upon or reserved to the stockholders.
