

# ARTICLES OF INCORPORATION OF <u>COPPER HILL, INC.</u>



#### ARTICLE I - NAME

The name of the corporation is: COPPER HILL, INC.

# ARTICLE II - DURATION

This corporation shall exist perpetually, commencing at the time of filing these Articles of Incorporation with the Secretary of State of the State of Florida.

#### ARTICLE III - PURPOSE
