ARTICLE I – NAME

The name of this corporation is BRYSON OF BREVARD INC. The principal office of this corporation is 451 RICHARD ROAD, ROCKLEDGE, FL 32955.

ARTICLE II – DURATION

This corporation shall exist perpetually. The date of commencement of the corporation shall be APRIL 1, 1999.

ARTICLE III – PURPOSE

This corporation is organized for the purpose of engaging in any business activity permitted under the laws of the UNITED STATES and the STATE OF FLORIDA.

ARTICLE IV – CAPITAL STOCK

This corporation is authorized to issue 500 shares of \$1.00 par value common stock.

ARTICLE V – PREEMPTIVE RIGHTS

ARTICLE X – COMPENSATION OF DIRECTORS

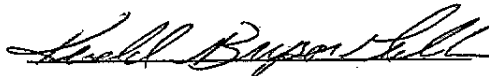
The shareholders of this corporation shall have the exclusive authority to fix the Compensation of directors of this corporation.
