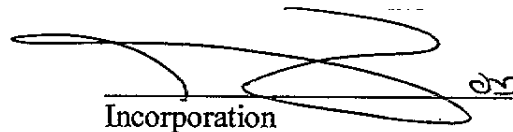

Professional Association

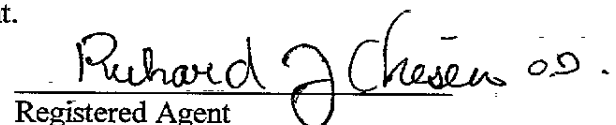
1. The name of the corporation shall be: *InVision Specialist of Oviedo, P.A.*
2. The purpose for which this corporation is organized is: *the practice of Optometry*
