The undersigned subscriber to these Articles of State
Incorporation, a natural person competent to contract, hereby forms
a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be National Temp to
Perm Recruiters, Inc. The principal place of business of this
corporation shall be 3117 W. Columbus Dr. Suite 207. Tampa, Florida
33607.

ARTICLE II. DURATION

This corporation is to exist perpetually, commencing with
the filing of these Articles of Incorporation with the Department
of State.

ARTICLE III. GENERAL PURPOSES

This corporation may engage in or transact any or all
lawful activities or business permitted under the laws of the
United States, the State of Florida or any other state, county,
territory or nation.

ARTICLE IV. CAPITAL STOCK
