ARTICLES OF INCORPORATION OF



THE CONSERVANCY COMPANY

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE 1. Name. The name of the Corporation is: **THE CONSERVANCY COMPANY.**
