ARTICLES OF INCORPORATION
OF

Article I - Name

The name of the Corporation is Tampa Bay Yachting Center, Inc.

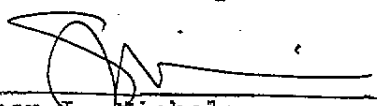
Article VII - Directors

Article VIII - Incorporator

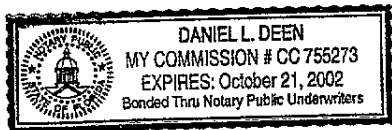

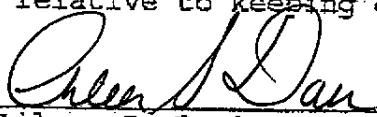
