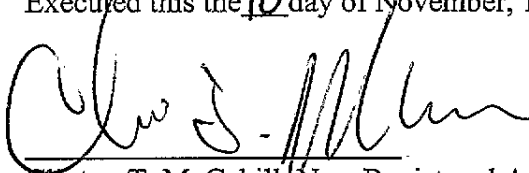
**CHANGE OF CORPORATION REGISTERED AGENT**

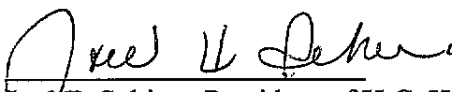
