**ARTICLES OF INCORPORATION
OF
EXQUISITE BRIDALS, INC.**

In compliance with the requirements of Chapter 607 of the Florida Statutes, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE 1. The name of the corporation ("Corporation") is EXQUISITE BRIDALS, INC.

ARTICLE 2. The street and mailing address of the principal office of the Corporation is 4221 Empress Street, Palm Beach Gardens, Florida 33410.

ARTICLE 3. The Corporation shall have: perpetual duration upon filing its articles of incorporation by the Department of State; succession in its corporate name; the powers an individual has to do all things necessary or convenient to carry out its business and affairs; and, all general and emergency powers provided for corporations pursuant to Chapter 607 of the Florida Statutes.

ARTICLE 4. The general purposes for which the Corporation is organized are to engage in the business of bridal service,

formal wear rental and sales, and custom dressmaking, tailoring and alterations, and to transact all lawful business for which corporations may be incorporated.

ARTICLE 5. The maximum number of shares the Corporation is authorized to issue is Five Hundred (500), all of which shall be Common Shares with a par value of One (\$1.00) Dollar per share. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

ARTICLE 6. The initial street address of the Corporation's registered office is 4221 Empress Street, Palm Beach Gardens, Florida 33410. The initial registered agent for the Corporation at that address is GERASIMOS KAMBITSIS, who is appointed registered agent pursuant to the provisions of Chapter 607 of the Florida Statutes for all purposes required by law, including the acceptance of service of process.

ARTICLE 7. The board of directors of the Corporation shall consist of at least one (1) but not more than three (3) members. The name and address of the person who will serve on the initial board of directors of this corporation and hold office for the first year or until a successor is chosen, is: GERASIMOS KAMBITSIS, 4221 Empress Street, Palm Beach Gardens, Florida 33410.

ARTICLE 8. The Corporation shall have the following officers: President, Vice President, Secretary and Treasurer. The following are the names and addresses of the first officers of the Corporation, who shall hold office for the first year or until their successors are chosen:

ARTICLE 9. The following is the name and street address of the person signing these article of incorporation as the incorporator of the Corporation, the number of shares of stock for which each has subscribed, and the value of the consideration each has paid therefor:

who has subscribed for 100 shares of common stock at par value.

ARTICLE 10. The Corporation shall indemnify its directors, officers, employees, and agents to the fullest extent permitted by law.

ARTICLE 11. These articles of incorporation may be amended

in the manner provided by law. Every amendment shall be approved by the directors of the Corporation, proposed by them to the stockholders and approved at a stockholder's meeting by a majority of the stockholders entitled to vote thereon, unless all directors and all of the stockholders sign a written statement manifesting their intention that a certain amendment of these articles of incorporation be made.

I, the undersigned incorporator, being the original subscriber to these articles of incorporation and to the capital stock as herein set forth, do hereby make and file this certificate hereby declaring and certifying the facts herein stated are true.

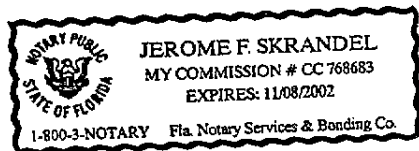



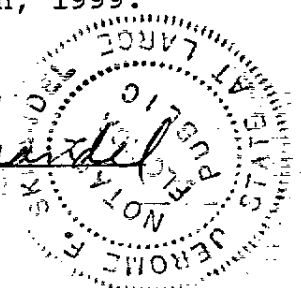
