While preparing a corporate return for the client listed above, I discovered that the client had not mailed the UBR due May 1, 2000. When I called the client to inquire about the tardiness in mailing the report, I was made aware that his wife had passed away April 19, 2000. Since she had always taken care of the tax information and other corporate filings, he did not know that the report had not been mailed or that it even existed. He was not in a state of mind that would have allowed him to recognize what the purpose of the form and that it had a deadline to be mailed. He simply gathered all the paperwork she had been compiling for their tax return, and mailed it to our firm for preparation of their 1999 Form 1120S.
