FIRST: The name of this corporation is J. HASKETT, INC.

SECOND: This corporation may engage in or transact any or all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, country, territory or nation.

THIRD: The maximum number of shares of stock that this Corporation is authorized to have outstanding at one time is one thousand (1,000) shares of common stock having a par value of ten cents (\$.10).

FOURTH: The amount of capital with which this Corporation will begin business is one hundred dollars (\$100.00).
