

ARTICLES OF INCORPORATION

OF

ARTICLE I. NAME

The name of this corporation is
SPACE COAST INSURANCE AGENCY, INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence.

ARTICLE III. PURPOSE


