ARTICLE I - NAME

The name of this corporation is ACCURATE DIAGNOSTIC SERVICES, INC.

ARTICLE II - DURATION

EFFECTIVE DATE
2-16-99

This duration of the corporation is perpetual and the date of the commencement of the corporate existence is the date of subscription and acknowledgment of these Articles of Incorporation, i.e., conditioned upon said Articles of Incorporation being filed by the Department of State within five (5) days, exclusive of legal holidays, after such date; otherwise, the commencement of the corporate existence shall be at the time of the filing of the Articles of Incorporation by the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV - CAPITAL STOCK

The corporation is authorized to issue 100 shares of one dollar (\$1.00) par value common stock.

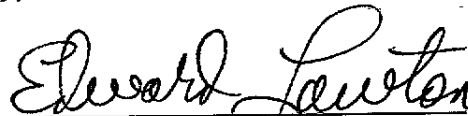
ARTICLE IX - INDEMNIFICATION

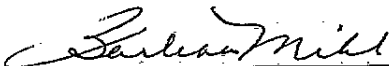

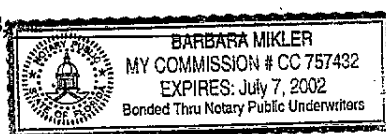
