**ARTICLE I.**

**NAME**

The name of the Corporation is: NATE LEVY ENTERPRISES, INC.

**ARTICLE II.**

**DURATION**

This Corporation shall have perpetual existence.

**ARTICLE III.**

**PURPOSE**

This Corporation is organized for the purpose of transacting any or all lawful business.

**ARTICLE IV.**

ARTICLE V.

INITIAL REGISTERED OFFICE AND AGENT
