Article I - Name

The name of the corporation is:

This corporation shall exist perpetually.

Article III - Purpose

Article IV - Capital Stock

This corporation is authorized to issue five hundred (500) shares of one Dollar (\$1.00) par value common stock which shall be designated "Common Shares".
