The name of the corporation shall be UN VERSETAL ENTERPRISES, INC.

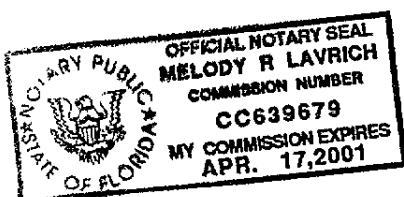

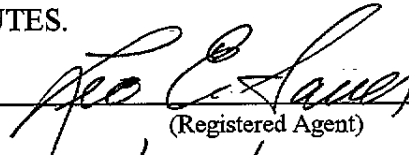
