## **ARTICLE 1 - NAME**

The name of this corporation is A Touch of Class Event Planning & Management Corp.

#### **ARTICLE II - DURATION**

The duration of the corporation shall be perpetual and shall commence upon the signing and acknowledging of these Articles.

#### **ARTICLE III - PURPOSE**


