

Articles of Incorporation

I. Name

The name of this corporation shall be : Southern Interiors, Inc.

II. Principal Place of Business

The principal place of business of this corporation shall be:

III. Authorized Shares

The initial number of authorized shares shall be one thousand (1000) shares of common stock, each with a par value of one (\$1.00) dollar.

IV. Duration

The duration of the corporation shall be perpetual.

V. Restrictions on Shares

All shares are restricted and may not be sold, transferred or encumbered in any way without the express written approval of the Board of Directors given at a meeting at which this issue is agendaed. In addition, unissued shares may not be transferred, sold or authorized for sale except by majority vote of the outstanding shares approving same (one share equals on vote). No shareholder shall have the pre-emptive right to acquire unissued shares of securities convertible into such shares or carrying a right to subscribe to or acquire such shares. The

VI. Initial Directors
