The undersigned subscriber to these articles of incorporation, being duly licensed to practice law in the State of Florida pursuant to the laws of the State of Florida, adopts these articles to form a professional association under the Professional Service Corporation Act, Chapter 621, Fla. Stat. (1993), and other laws of the State of Florida.

ARTICLE I - NAME AND ADDRESS

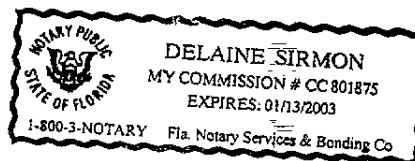
