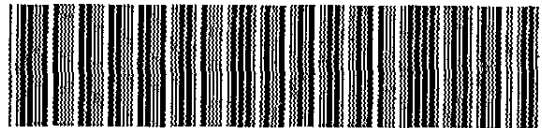

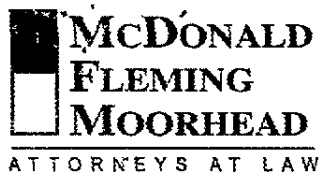

The corporation is dissolved effective December 31, 2003. Dissolution was authorized on December 31, 2003.

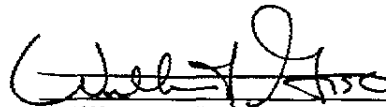
ARTICLE III – APPROVAL
