ARTICLES OF INCORPORATION
OF

In compliance with the requirements of F.S. Chapter 607, the undersigned, being natural persons, do hereby act as incorporators in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I
NAME

The name of the corporation ("Corporation") is **SWEEP EXPECTATIONS, INC.**

ARTICLE II
EFFECTIVE DATE

The existence of the corporation shall begin upon filing with the Secretary of State.

ARTICLE IV
CAPITAL STOCK

The maximum number of shares this Corporation is authorized to issue is **ten thousand (10,000)**, all of which shall be Common Shares.
