The undersigned, for the purpose of forming a Corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

Article I - Name; Principal Office

The name of this Corporation shall be **CENTRAL FLORIDA LIGHTING & SUPPLY, INC.** (the "Corporation"). The street address and the mailing address of the initial principal office of the Corporation shall be 6317 Cheryl Street, Orlando, Florida 32819, or such other place as may be designated by the Board of Directors.

The date of commencement of corporate existence shall be effective as of March 24, 1999. The Corporation shall have perpetual existence.

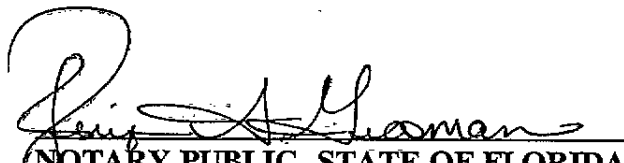

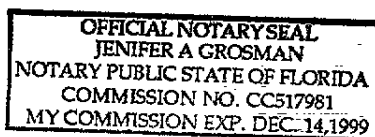
