ARTICLES OF INCORPORATION

OF

ANTBAR CORPORATION

ARTICLE I
NAME

The name of the corporation is ANTBAR CORPORATION (hereinafter called the ("Corporation")).

ARTICLE II
INITIAL ADDRESS

The address of the principal office and the mailing address of the Corporation is 9375 N.W. 8th Avenue, Miami, Florida 33150.

ARTICLE III
AUTHORIZED SHARES

The capital stock authorized, the par value thereof, and the characteristics of such stock shall be as follows:

ARTICLE IV

- (2) If the holders of not less than 50 percent of the persons entitled to vote on any issue proposed to be considered at the proposed special meeting sign, date, and deliver to the Corporation's secretary one or more written demands for the meeting describing the purpose or purposes for which it is to be held.

ARTICLE V
REGISTERED AGENT

ARTICLE VI
BOARD OF DIRECTORS AND ELECTION

The corporation shall have a Board of Directors consisting of at least one (1) director. The corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment to them, and all rights privileges

conferred upon any Shareholders, Directors, and Officers are subject to this reservation. The Articles of Incorporation may be amended in accordance with the provisions of the laws of the State of Florida, as amended from time to time, unless more specific provisions for amendments are adopted by the corporation.
