## ARTICLES OF INCORPORATION

OF

## ALAN'S HOME IMPROVEMENTS, INC

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

## ARTICLE I.

The name of this corporation is;

ALAN'S HOME IMPROVEMENTS, INC

ARTICLE II. NATURE OF BUSINESS

The corporation may engage in any activities or business permitted under the laws of the United States and of the State of Florida.

In addition, the corporation can invest in real estate, mortgages, stocks, bonds, or any other type of investment and can own real and personal property.

# ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any time shall be as follows: Five Hundred (500) shares of IRS Section 1244 common stock having a par value of \$1.00 per share. The consideration to be paid for each share shall be as fixed by the board of directors, and may take the form of services rendered, cash, property, or any other forms deemed satisfactory by the board of directors.

## ARTICLE IV. INITIAL CAPITAL

The amount of capital with which this corporation  $\underline{\underline{w}}$  ill begin business shall not be less than Five Hundred (\$500.00).

## ARTICLE V. TERMS OF EXISTENCE

The corporation is to exist perpetually.

# ARTICLE VI. ADDRESS

The initial street address of the principal office of the corporation in the State of Florida shall be: ALAN'S HOME IMPROVEMENTS, INC, 528 S. LAKE PLEASANT ROAD, APOPKA, FLORIDA 32703. The board of directors may from time to time move its principal office to any other place or places as may be designated by the board of directors.
