The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

**Article 1. Name.**

The name of this Corporation is:

**Accounting First, Inc.**

**Article 2. Duration.**

This corporation shall have perpetual existence commencing on the date that these Articles are formally accepted by the office of the Secretary of State for the State of Florida.

**Article 3. Purpose.**

This corporation is organized for the purpose of transacting any or all lawful business.

**Article 4. Capital Stock.**

The aggregate number of shares which the Corporation is authorized to issue is FIVE HUNDRED (500) shares of common stock. Such shares shall be of a single class and shall have a par value of \$1.00 per share.

**Article 5. Address.**

**Article 6. Pre-emptive Rights.**

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series in that which he already holds, shall have the right to purchase his pro-rata share (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to the others.

**Article 7. Initial Registered Office and Agent.**

**Article 8. Board of Directors.**
