The undersigned incorporator hereby forms the following corporation under the laws of the state of Florida.

**ARTICLE I
NAME**

PURPOSE**

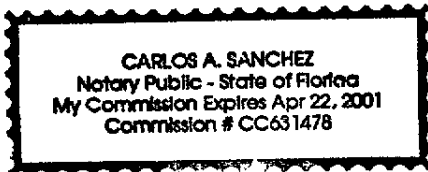
